- A. Employment information on school letterhead verifying full time employment and start date;
- B. Copy of contract from the school board;
- C. Birth Certificate (for dependent applicant);
- D. Marriage Certificate (if applicable);
- E. U.S. Court appointed guardianship paperwork (if applicable);
- F. Verification of Lawful Presence: https://registrar.gatech.edu/info/lawful-presence Indepedent students are required to submit items A, B and F only.
