## NON-RESIDENT REQUESTING CONSIDERATION FOR AN OUT-OF-STATE TUITION DIFFERENTIAL WAIVER

Career Consular - Dependent students and spouses are required to submit the following information from their parent or spouse:

- A. A statement on letterhead from the office verifying the consular officer is stationed and living in Georgia under orders of their respective government;
- B. Birth Certificate (for dependent applicant);
- C. Marriage Certificate (if applicable);
- D. For the first semester, a copy of the A visa is required;
- E. Verification of Lawful Presence: https://registrar.gatech.edu/info/lawful-presence Independent applicants are required to submit items A, D and E only.
